

Centrelink, Same-sex Law Reform and You



From the 1st July 2009, Centrelink will be recognising same-sex de-facto couples for the purpose of assessing benefit levels. These reforms were announced in late 2008, and are designed to remove discriminatory practices within government policy.

Essentially, same-sex couples will be assessed in the same way that heterosexual couples have been, when receiving Centrelink benefits.

What does this mean for you?

What do I have to do?

From March 30 2009, you can advise Centrelink if you are currently living with a partner. Reassessments won't actually be done until July 1st.

What can happen to me if I don't register?

Centrelink will have the right to investigate, and prosecute, people who do not disclose their same-sex relationship. After July 1st, any overpayments may have to be paid back to Centrelink.

So who is a partner?

Everybody's relationship is different and as individual as the people in them. A 'partner' is deemed to be someone that you share a home with, own joint assets with (like cars or furniture), share the same group of friends and/or have sex with.

What forms do I have to fill in?

The Living Arrangement Form
The Income and Assets Form

What if I don't agree with the assessment?

You can appeal. You can speak with the Customer Service Office and ask for the Reviews and Appeals Fact Sheet, which can be found on the Centrelink website.

Who can I go?

PD, QPP and QAHC are here to support you. While we cannot advise you about your legal rights or obligations, we are available to support you by talking to you about your concerns and fears, or helping you complete the forms, or use the on-line calculator on the Centrelink website.

What does this mean for you?

What if I have specific questions about how the law reform will impact me?

For answers to specific questions, you will need to speak with Centrelink directly. To obtain independent advice you can also contact the Welfare Rights Association* (Queensland) at www.wrcqld.org.au/ or phone 07-3847 5532 or 1800 358 511.

Can I call Centrelink anonymously?

Yes you can. You can call the Centrelink Enquiry Line on 13 62 80 to speak with a person anonymously about your circumstances and the impact that this reform may have for you and your partner/s.

When will my DSP or other type of pension be affected?

Unfortunately, we are unable to answer this question as every person's circumstance is individual. This is an example of when you can get SUPPORT from QPP, PD or QAHC, and INFORMATION from Centrelink by contacting them for direction and advice.

Is there an information pack from Centrelink?

Yes. The Centrelink website has all the information that you require including:

- Centrelink recognises same sex relationships fact sheet
- Financial information service fact sheet
- Your right to privacy fact sheet
- Reviews and appeals fact sheet
- Guide to Australian government payments booklet

So what do I do now?

If you are a person living with HIV, you can call Positive Directions and speak to a Client Liaison Officer in your local area for information and support. Alternatively, you might like to call QPP.

IF you are a member of the LGBT community, you can contact QAHC.

Just remember, there is support available.
